Secretary's report accepted as read, motion by: Ray Hummel, 2nd by: Ira Lessman, Motion carried.

Treasurer's report accepted as read, motion by: Perry Aitkin, 2nd by: Kenny Frymoyer, Motion carried.

Old Business: Carl Landis read a letter from the audit committee that said everything was good with the Treasurer's books.

Ronnie Hauck talked about the events to be held at the spring show like a folding display contest for the kids. They might need space for this in the barn. He made up and passed out a schedule of events for the SUN Area Ag/Dairy Days to be held at the show. There will be kids activities all three days, celebrity milking contest, kids pedal pulls, dairy princess pageant and the ice cream sundae. There are also other events being worked on like having the Soil Conservation and Bureau of Forestry come out and maybe we could have Smokey the Bear come out as well.

Also discussed having a Farm/Ag Safety Event which would be done by the local fire companies and if weather permits, we could have Life Flight show up as part of the Ag safety event. This would be held on Saturday.
