Membership Meeting

Date held: February 10, 2015

There were 15 members in attendance.

Secretary's report was read and one correction was made, the amount in the bank was \$14,892.69.

Secretary's report accepted as read and corrected, motion by: Ira Lessman, 2nd by: Ronnie Hauck, Motion carried.

Amount in the bank: \$14,142.02

CD: \$4,009.23

Reported profit from January scrapple: \$671.56

Treasurer's report accepted as read, motion by: Todd Willow, 2nd by: Jeff Radel, Motion carried.

Old Business: The Spring Show brochures are finished. They will be picked up as soon as Scott comes back from vacation.

Discussed the fall show brochures. We need to go over the dates for the 2016 shows and we also need to get entertainment for the fall show. The spring show dates will be May 20-22, 2016 and the Fall Show dates are August 26-28, 2016. We then discussed the entertainment for the fall show. Josh Martin will check on 2 country music groups that he knows about and get back to us with prices and availability.

Todd Willow mentioned that he checked on propane prices at Sensing's. They want \$475 for the tanks and \$60 for the regulators. Right now they will fill 100 lb. tanks for \$50.00. He also mentioned that Sensing's contracts with Kopy's to go out and fill tanks. We would be able to get a 10 cent discount because we have more than 2 tanks. Mike Lessman mentioned that he would check with Moyers and see if we have a contract with them and to see what we pay.

Discussed getting ice for the shows. Ray Hummel is having a hard time finding a place to get it from. Jeff Radel said that he would check with Weis Markets to see if we can get a skid of 100 8lb. bags of ice and what it would cost us.

Todd Willow also mentioned that he checked on prices at Sam's Club for frying oil. Right now it is \$19.99. The prices are starting to go up.

We then discussed getting shirts. Todd found a place that would sell us shirts \$10.50 for small-XL, \$11.50 for 2XL-3XL, with a pocket for \$11.00 for small-XL and \$12.00 for 2XL-3XL. Hoodies

would be \$20.00 for S-XL and \$21.00 for 2XL-3XL and zipper hoodies would be \$22.00 for S-XL and \$27.00 for 2XL-3XL. The design would be on both sides and one color ink.

Mike Lessman mentioned that Greg Bingaman found a place that we could get from and the t-shirts would be \$7.00 with no pocket and \$8.50 with a pocket and \$10.50 for 2XL. The hoodies would be \$19.00 for S-XL and \$21.00 for 2XL and zipper hoodies would be \$24.00 for S-XL and \$26.00 for 2XL. Todd said that the printer is afraid that the image might bleed because of the detail of the pictures. We had some good comments about the design that we came up with.

Discussed the dates for the Garden Tractor Pulls. The dates for this year are: May 24th, July 4th and September 5th.

The dates for the Snyder County Tractor Pulls are: April 19th (Test and Tune) May 30th, June 20th and August 1st with the possibility of having a 4th pull on October 2nd.

Ray Hummel mentioned that we should see if we could let our grounds out to more camping clubs. It was mentioned that there aren't that many around anymore. We also don't have enough electric to supply a lot of campers.

New Business: Discussed the opportunity to go to McVeytown for their Country Memories Day to make chips. This event will be held on May 23rd which is the week after our Spring Show. Also, the invitation says that food vendors need to be self-contained. We need water, electric and drainage to make chips. After discussion, Nancy Lessman made a motion not to attend, 2nd by: Delphia Lohr, Motion carried.

Todd Willow found a stainless steel 2 pump ketchup and mustard dispenser for \$20.00 and he wondered if the club wanted it for the food stands. It takes a bag or box of ketchup and mustard. Ray Hummel made a motion to buy it, 2nd by: Jeff Radel, Motion carried.

We will be making scrapple and sausage on February 27th and 28th. We will be doing 4 hogs again. It was also mentioned that we will be needing lots of help and that this will probably be the last time we make scrapple for the season.

Discussed the CD. The question was asked if we should add to it or not. It is a no fault CD, so we can add to it or take out of it at any time without penalty. Mike Smith made a motion to renew the CD with another no fault CD 2nd by: Ronnie Hauck, Motion carried.

Ronnie Hauck asked if we were going to be getting the tents again for the Spring Show for the activity area. We will need to check on getting the tents again.

Ronnie also mentioned that the SUN Area Dairy Princess Promotion is working on getting things together for the Spring Show.

Discussed asking around for sponsors for our entertainment. It was mentioned that we could ask the businesses that we buy products and supplies from if they would like to help sponsor our entertainment.

Discussed the frying oil again to see what we should do since the prices are starting to go back up. Should we get it now or wait. It was decided to wait to see what the prices continue to do.

The show books are \$10.50 this year so we will be selling them for \$11.00.
