Secretary's report accepted as read, motion by: Perry Aitkin, 2<sup>nd</sup> by: Ira Lessman, Motion carried.

**Old Business:** Discussed the water line that needs to be installed at the track. After discussion, Kenny Frymoyer made a motion to install a water line to the announcers stand at the track, 2<sup>nd</sup> by: Brad Bingaman, Motion carried.

Secretary then read an e-mail from Terri Keitel about the Show Directory and why our shows ad was not placed in it this year. Terri states that the e-mail with the ad was received but was overlooked.

**New Business:** Discussed going to the "Days Gone By" Antique Tractor, Car and Truck Show to be held on June 9<sup>th</sup> and 10<sup>th</sup> in Lewisburg to make french fries and maybe chips. After discussion, Kenny Frymoyer made a motion to go to the show, 2<sup>nd</sup> by: Perry Aitkin, Motion carried.

Mahlon Boop reported that the American Heritage Crafters event in Milton will be held on April 21<sup>st</sup>.

Dave Daku also reported that there will be an added tractor pull for the Snyder County Tractor Pullers which will be held on September 8<sup>th</sup> and this will be an Interstate Pull.

Discussed the Freeburg parade. Gary Klingler would like to know if the Association would be interested in attending this year's parade.

The parade will be held on Thursday, June 14<sup>th</sup> at 7:00 PM. We need to find out if there is any parking for trucks and trailers and what time the parade forms.

Dave Daku mentioned that the Snyder County Tractor Pullers are going to start working on the bleachers on April 1<sup>st</sup>.

It was also mentioned that the bacon and sausage is done and in the freezer.

The Track Side Food Stand has been expanded.

Greg Bingaman mentioned that they could get pizzas for the Track Side Food Stand at Aldis that are pre-made. Greg said he needs to find out if they can get them by the case.

Discussed the food prices for this year and if we should raise them. It was mentioned that the prices of the hogs for the bacon and sausage went up 7 cents per pound. After discussion Kenny Frymoyer made a motion to raise the food prices 25 cents, 2<sup>nd</sup> by Brad Bingaman, Motion carried. It was then discussed that the sausage sandwiches should be raised 50 cents to make them \$4.00 and the hot dogs should remain at \$1.50. Kenny Frymoyer then made an amendment to the motion to keep the hot dog prices the same and raise the sausage sandwich price to \$4.00, 2<sup>nd</sup> by: Dave Daku, Motion carried.
