Secretary's report accepted as read, motion by: John Malcolm, 2nd by: Donald Athey, Motion carried.

Treasurer's report accepted as read, motion by: Perry Aitkin, 2nd by: Dawn Betz, Motion carried.

Old Business: Read and discussed the "Agreement for Occasional use of Grounds".

After reading over the agreement, Ira Lessman made a motion to accept the Agreement for Occasional use of Grounds, 2nd by: Perry Aitkin, Motion carried.

Read and discussed the rules and regulations that were made for the show grounds. An amendment was made to the first rule, making it "No alcoholic beverages or illicit drugs permitted on the grounds". These rules will be hung in the bulletin board on the food building and in the pavilion.

Discussed letting out the pavilion and the show grounds. We need to let people know that would be interested in using the grounds that there are no restroom facilities on the grounds.
