There were 18 members in attendance.

Secretary's report accepted as read, motion by: John Malcolm, 2<sup>nd</sup> by: Donald Athey, Motion carried.

Amount in the bank: \$8,410.10

CD: \$10,000.00

Treasurer's report accepted as read, motion by: John Malcolm, 2<sup>nd</sup> by: Perry Aitkin, Motion carried.

**Old Business:** Discussed advertising in the Snyder County Post. Our show dates will be posted on the "Upcoming Events" page, but we were also offered a space to place our ad on that page as well. It would cost \$45.00 for the ad per week and we were offered a 50% non-profit discount per week so it would only cost us \$22.50 per week. After discussion, Donald Athey made a motion to place the ad for 2 weeks on the Snyder County Post web site, 2<sup>nd</sup> by: Todd Willow, Motion carried.

Discussed getting ice for the show. Sam Yoder will use the ice from us to make his ice cream. It was decided to get the ice from over at Sunbury. They will only charge us for what we use.

The Boy Scouts will be coming to the show and will have their food stand open.

The Mountain Man will be coming to the show as well. He will come in on Thursday and will be leaving on Saturday.

Our ad has been placed in the Daily Item for Monday the 23<sup>rd</sup>. They would like to know if we are interested in placing our ad in the Danville News. One day would be \$40.00 and two days would be \$80.00. After discussion, Ira Lessman made a motion to place the ad in the Danville News for 2 days, 2<sup>nd</sup> by: John Malcolm, Motion carried.

Discussed placing our ad on the local radio stations. Our show has been placed on Wheels 106.1 Calendar of Events on their web site. Our show info has also been sent to Max Media and will be placed on Big country's and Y106.5's web sites. Our show will also be run on Big Country radio when it gets closer to show time. We have not heard back from Sunbury Broadcasting Corporation.

We can not get the helicopter to come to the show.

The Old Iron calendars are in. We are charging \$5.00 each.

Discussed if we should make chips to sell at the Kratzerville Carnival. Ira Lessman made a motion that we do not go to Kratzerville to sell chips. After some discussion, John Malcolm made an amendment to the motion that we only go if we have a surplus of chips and help, 2<sup>nd</sup> by: Donna Moyer, Motion carried. Ira Lessman's motion failed due to lack of a 2<sup>nd</sup>.

Discussed how many potatoes we should get. After discussion, Todd Willow made a motion that we get 60 bags of potatoes for the show, 2<sup>nd</sup> by Donald Athey, Motion carried. We need to find out how many potatoes we will need for the Selinsgrove Street Fair. Also discussed how much oil we need. It was discussed that we will need 8-10 jugs of oil for at the street fair and around the same amount for at Richfield. Ray Hummel made a motion that we get a skid of oil, 2<sup>nd</sup> by: Todd Willow, Motion carried.

**New Business:** It was reported that Joanne Lindsey is doing well and is getting around.

Discussed the bulk tank that is in the ground at the Quonset hut end of the show grounds. It was asked if we can get a lid for the tank to keep kids out and to keep anyone from falling in. It was decided to place plywood over the tank for now until we come up with something else.

Discussed getting entertainment for next year. Ray Hummel found a group (Covert Action) for \$1000.00 for next year. It was suggested combining our budget and having one night of entertainment on Saturday. It was also suggested that if we can get them, we will need to advertise that we are having them for entertainment. Ira Lessman made a motion to get Covert Action for next Spring and Fall shows, 2<sup>nd</sup> by: George Frymoyer and after discussion, Motion carried.

Discussed Al Parks companion Mary who fell out of their RV. Ray Hummel reported that she is in good spirits but is in really bad shape. A card has been sent.

A card will also be sent to the John Swinehart family.

It was also mentioned that Nancy Lessman had knee replacement surgery today.

**Unfinished Business:** New lighting in the barn, discussing doing a Halloween event and the steam air compressor.
