There were 12 members in attendance.

Secretary's report accepted as read, motion by: Todd Willow, 2nd by: Kenny Frymoyer, Motion carried.

Amount in the bank: \$6,412.27

CD: \$11,000.00

Treasurer's report accepted as read, motion by: Perry Aitkin, 2nd by: Kenny Frymoyer, Motion carried.

Old Business: The Daily Item ad is set to run on Wednesday August 24th in the Daily Item and the Danville News.

The dumpster is ordered and set to be delivered on Wednesday August 24th and picked up on Tuesday August 30th.

Discussed the Puppen Meister Productions Marionette show. He will need two 20 Amp, 120 volt outlets to plug into and he will only need 30'x70' of space. We will need to find a place to put him. It was suggested that we could place him by the main electrical poles at the end of the food row or we could place him at the pole down by the barn in the last flea market row if he will fit in there or we could place him up by the train station. We can figure this out the week of the show when he comes.

Contacted Tara Beck at B 98.3 radio and sent her the ad and billing information for the show and she would like to know what days we would like to advertise. It was decided to advertise on Thursday August 25th and Friday August 26th, 3 ads per day.

Ray Hummel asked if we would like to keep advertising on WQSU radio after the show is over. It was decided to stop advertising with them at the end of November after the basket bingo and Richfield's "Christmas in the Park" are over.

Kenny Frymoyer picked up the fryers and grills that the Snyder County Tractor Pullers have and he is in the process of cleaning them up.

Kenny also said that he can get pieces of Formica and laminate to make counter tops for the new food building at the track.

Mahlon Boop mentioned that he can get potatoes for the show for \$12.00 per 50 pound bag. He will be picking them up on August 24th.

New Business: We received the papers for next year's Visitors Guide from the Susquehanna River Valley Visitors Bureau asking if we would like to advertise in this guide. It was decided not to because of the price. Our shows will be mentioned in it for free.

Nancy Lessman mentioned that we have a lot of food and supplies left over from the spring show that we are going to use up at the fall show. This will help with the cost of the show.

The question was asked, what can we do to get more people to come to the meetings? There used to be a lot more people attending. There seems to be a lack of interest from the members.

Discussed things that need to be done for the show. The flea market roads need to be sprayed because you can't see the stones anymore. We also need to get the propane tanks filled at the food building and we will need at least 3 propane tanks for at the new food stand at the track.

Unfinished Business: Discussing doing a Halloween event, making a place to work at the show grounds, advertising on the restaurant t.v.'s, installing a motion light on the barn, rebuilding the BBQ pit and getting a roof for the BBQ pit.
